The MSc in WBME is a three yr part time programme aimed at clinicians with educational roles and responsibilities. The programme has a strong practice based approach, designed to address the development needs of those new to medical education and training. The participants are located in diverse NHS settings, mostly hospitals and GP practices. The programme has been designed for busy people who find it difficult to meet face to face as a group. A prerequisite is an interest in improving their own medical education practice. Utilising EBL this project offers an opportunity to develop an innovative method of programme development and support for programme participants.

Aim

To build a community of accredited medical education practitioners and facilitate their development in the field of medical education using online enquiry-based learning.

Objectives

- To enhance links between the University of Manchester and the NHS
